B. Ellen Byrne, DDS, PhD

Ellen Byrne has a BS in Pharmacy, DDS, General Practice Residency, Certificate in Endodontics and a PhD in Pharmacology and Toxicology. She is currently Senior Associate Dean and Professor of Endodontics at Virginia Commonwealth University, School of Dentistry. Dr. Byrne's fast moving pharmacology presentation will review medications currently prescribed by dentists and medications most currently used by children. The reviews will include dosing information, side-effect and clinical significant drug interactions. At the end of this presentation the participant will be able to:

- *recognize clinically significant drug interactions
- *recognize that dosing in children is not a simple extrapolation from adult doses
- *discuss indication of pain medication in children

Dr. John Svirsky is a board certified oral and maxillofacial pathologist at Virginia Commonwealth University in Richmond, VA. He maintains a private practice in oral medicine and oral pathology. Dr. Svirsky has developed a broad background in research, published numerous articles in the dental literature and earned a Master's Degree in adult education.
