The President's Message

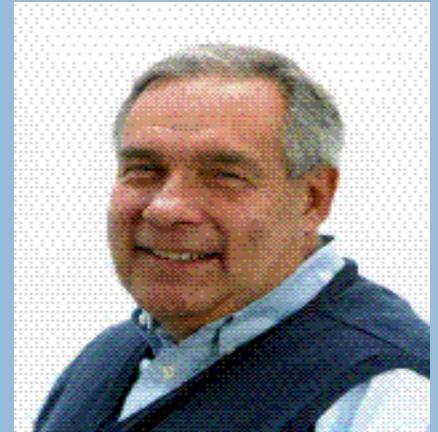

Considerations of Temporomandibular Disorders in Children and Adults

About the Course:

Most TMD symptoms are reported in adults but young adolescents and children can sometimes present to the dental office with these symptoms. The management of temporomandibular disorders is sometimes complex problem in dentistry. This complexity arises from the many different disorders that can be present as orofacial pain in the masticatory structures. In order to effectively manage TM disorders the clinician must first be able to differentiate these disorders from other orofacial pain conditions. Once a proper diagnosis is established the clinician can then select the appropriate therapy that will best resolve the disorder. Dr. Okeson and Gremillion have developed a sound and straightforward approach to understanding and treating many masticatory pain problems. Treatment based on sound scientific principles will be presented. Emphasis will be placed on diagnosis so that correct therapy will be selected for each patient. Appropriate use and fabrication of occlusal appliances will be discussed. Indications for dental therapy in the overall management of TM disorders and the role of the dental specialists will be presented in detail. This course will benefit all practitioners.

What You Will Learn:

- To identify those pain disorders that will likely respond to your therapy from those that will not.
- The relationship between occlusion, bruxism and temporomandibular disorders.
- The most favorable condylar position for restorative dentistry and TMD.
- To differentiate those cases that may respond to orthodontic procedures from those that will not.
- The relationship between orthodontic therapy and TMD: Cause or Prevention.
- When it is appropriate to consider surgical therapy for a patient.
- The appropriate use of occlusal appliance therapy.
- Differential diagnosis of headaches in children
- Potential causes of sleep-related bruxism

HENRY A. GREMILLION, D.D.S. BIOGRAPHICAL SKETCH

Dr. Henry A. Gremillion is a 1977 graduate of Louisiana State University School of Dentistry. He maintained a private general dental practice in Cottonport, Louisiana from 1977 to 1989. He then completed a 2 year Fellowship in Craniofacial Pain and Dysfunction at the University of Florida College of Dentistry under the mentorship of Dr. Parker E. Mahan. Currently he serves as the P. E. Mahan Endowed Professor in Orofacial Pain in the Department of Orthodontics and holds an affiliate appointment in the Department of Prosthodontics at the UFCD. He served as director of the Parker E. Mahan Facial Pain Center and directed a fellowship program in orofacial pain for the past 16 years and is on the active dental staff of Shands Teaching Hospital. He serves as a consultant in the field of temporomandibular disorders and orofacial pain for the U.S. Army, U.S. Navy, U.S. Air Force, Veteran's Administration Hospital in Gainesville, FL., ADA Council on Dental Practice, and the Comprehensive Dentistry Program at UFCD. He is an associate faculty member and of the Dawson Academy for Advanced Dental Study. He also serves on the editorial boards of the Journal of Prosthetic Dentistry, Journal of Craniomandibular Practice, and Journal of the Academy of General Dentistry. He has lectured extensively in the U.S. and abroad and has authored/co-authored numerous scientific articles, abstracts, and book chapters. His research interests include temporomandibular disorders, bruxism, and psychosocial aspects of orofacial pain. His major clinical interest is the diagnosis and management of orofacial pain.

Dr. Okeson is Professor, Chairman of the Department of Oral Health Science and Director of the College's Orofacial Pain Center, which he established in 1977. His textbook entitled Management of Temporomandibular Disorders and Occlusion is presently in its sixth edition and used in most dental schools in the United States. It has been translated into nine foreign languages for use abroad. In addition to this text, Dr. Okeson has authored the sixth edition of Bell's Orofacial Pains.

Dr. Okeson has more than 200 publications in the area of orofacial pain and TMD and has been very active in the development of graduate training programs in the area of orofacial pain. He is past president of the American Academy of Orofacial Pain and founding Diplomate and past president of the American Board of Orofacial Pain. He is the editor of the third edition of the American Academy of Orofacial Pain's Guidelines for the Classification, Assessment, and Management of Orofacial Pain. Dr. Okeson has presented more than 700 invited lectures on the subject of TMD and orofacial pain in 48 different states and in 42 foreign countries.

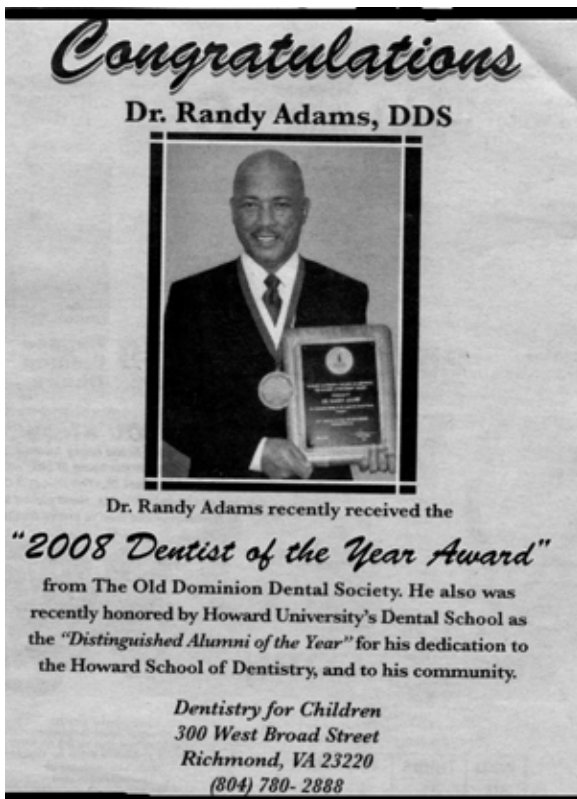

It is a privilege to present my first Trustee Report to the District III members of the American Academy of Pediatric Dentistry.

AAPD Annual Session

The Washington, D.C. meeting was a huge success with near record attendance, excellent continuing education, and wonderful social events. The meeting was the culmination of another year of hard work for those who volunteer to serve in various roles in the organization. One example of this commitment is our Council on Clinical Affairs' members who reviewed, updated or created more than 20 policies and guidelines to assist you in providing care to your patients. In our democratic process, all of these were presented to the membership for review and approved during the general assembly. Minutes of the General Assembly and Board Meetings are available on the AAPD website in the resource section.

District III is well represented in the leadership of the AAPD. Beverly Largent (KY) was installed as President during the General Assembly. Other members installed as officers include Rhea Haugseth (GA) -Secretary, Pitts Hinson (TN) - Parliamentarian, and Scott Cashion (NC) -Trustee at Large.

The Annual Session was preceded by Lobby Day, in which over 150 pediatric dentists met with their Senators and Congress members to discuss issues related to improving the oral health of children. Direct contact with our legislators is vital to advance the children's oral health issues. Please consider participating in our next Lobby Day in March.

Headstart

The AAPD and Office of Headstart have partnered to help provide a dental home to children enrolled in the Headstart program. The Head Start Dental Home Initiative plans to develop a network of pediatric dentists and general dentists to address the oral health access issues of this population. Tennessee has been selected as one of

the six pilot states. The Headstart Regional Consultants (which are geographically different from AAPD Districts) in District III include: Reneida Reyes, D.D.S. (serving Puerto Rico); Harold Goodman, D.M.D. (serving VA and WV); and Nicholas Mosca, D.D.S (serving AL, FL, GA, KY, MS, NC, SC, TN). Be on the lookout for ways to be involved as the program progresses.

AAPD Headquarters

The Staff and Leadership in Chicago continue to work on your behalf. These wonderful people are listed in the Resources section of the Members Page on the Website. One recent addition to the staff is Mary Essling, the Dental Benefits Manager, who is there to assist should you have questions or issues regarding dental benefit plans. Another service is the AAPD Member's website, which provides helpful information, such as policies and guidelines of the AAPD, journal articles, upcoming CE, etc. I would encourage you to explore it regularly.
